Department of Mining, Metals and Materials Engineering

M.Eng. in Mining Engineering; Project – Inter-University Mining (45 cr.)

Professor Mitri joined the meeting to discuss this new option of an existing program proposal. It will be jointly offered with McGill, Université Laval, École polytechnique and Université du Québec en Abitibi-Témiscamingue (UQAT).
